The operators provide AEx e II protection when installed into a Listed, Recognized or Classified increased safety enclosure.

Lamp modules.

Class I, Zone 1, AEx me II. Cat. No. 07-334-1 or -3 followed by -1 or -3, followed by -1, followed by -1, -2, -3, -4 or -5, may be followed by additional suffixes. Pilot lights are provided with operators; Cat. No. 05-0003-00 followed by -13, -14, -15, -16 or -17, may be followed by additional suffixes. The operators provide AEx e II protection when installed into a Listed, Recognized or Classified increased safety enclosure.

Class I, Zone 1, AEx d IIC.

Cat. No. 07-3353 followed by -3, followed by -1, followed by -1, -2, -3, -4 or -5, may be followed by additional suffixes. Lamp modules are provided with operators, Cat. No. 05-0003-00 followed by -13, -14, -15, -16 or -17, may be followed by additional suffixes. Operators provide AEx e II protection when installed into a Listed, Recognized or Classified increased safety enclosure.

Class I, Zone 1, AEx de IIC.

Cat. No. 07-335 followed by -1 or -3, followed by -1, followed by -1, followed by -1, -2, -3, -4 or -5, followed by -0, may be followed by additional suffixes. Lamp modules are provided with operators, Cat. No. 05-0003-00 followed by -13, -14, -15, -16 or -17, may be followed by additional suffixes. Operators provide AEx e II protection when installed into a Listed, Recognized or Classified increased safety enclosure.

Class I, Zone 1, AEx de IIC: Illuminated push-button modules, Cat. Nos. 07-336, followed by 1 or -3, followed by -1, followed by -7 or -8, followed by -1, -2, -3, -4 or -5, followed by -0, may be followed by additional suffixes. Illuminated push-button modules are provided with operators, Cat. No. 05-0003-00, followed by -65, -66, -67, -68 or -69, may be followed by additional suffixes. Operators provide AEx e II protection when installed into a Listed, Recognized or Classified increased safety enclosure.

Class I, Zone 1, AEx d IIC: Illuminated push-button module, Cat. Nos. 07-336, followed by 3, followed by -3, followed by -7 or -8, followed by -1, -2, -3, -4 or -5, may be followed by additional suffixes. Illuminated push-buttons modules are provided with operators, Cat. No. 05-0003-00, followed by -65, -66, -67, -68 or -69, may be followed by additional suffixes. Operators provide AEx e II protection when installed into a Listed, Recognized or Classified increased safety enclosure.

Auxiliary device enclosures.

Class I, Zone 1, AEx e II. Cat. Nos. 07-3511, 07-3512, 07-3513. Enclosures may be provided with a stop plug. Cat. No. 05-0003-00-19 may be followed by additional suffixes. Enclosure Types 4, 4X for indoor use.
